9. General Terms and conditions

1. Must have good physique
2. Must know cycling and have two wheeler license.
3. Preference will be given to candidates residing nearby Branches.
4. SC/ST/OBC candidates should enclose attested copies of Caste Certificate issued by Competent Authority, ie. Revenue Officer not below the rank of Tahsildar (Repatriates should enclose attested copies of proof) . In the absence of the certificates they will be treated as general candidates.

10. Application fee including postage charges (Non-refundable) is Nil for SC/ST/Repatriates and Rs.150 for General and others. The application fee must be Paid upfront by means of Bank Pay Order or Bank Demand Draft issued by Scheduled Bank payable at Chennai and should be drawn in favor of "REPCO BANK RECRUITMENT CELL".
11. The applicant should write his name and address on the backside of the Demand Draft/Pay Order. Application not accompanied by the Demand Draft/Bank Pay order will not be considered for to the examination.
12. Chennai will be the examination centre. Venue address will be given in the call letter. Candidates will have to make their own arrangements for taking the written examination and meet all the expenditure connected with it.
